- **Carpeted Floors**
- Booth sizes vary: 10'x10', 10'x20', and 20'x20' booths available
- Tabletops and Outdoor space available
- Free standing displays only
- *Full refund if show canceled before or on February 12<sup>th</sup>, then partial refund after February 12<sup>th</sup>.*
- Will follow CDC, state, and local health department guidelines.

## Booth Pricing:

### 10'x10' Booths

- \*Member Rates: **\$450 per booth for members**
- Non-Member Rates: **\$550 per booth for non-member**

### 10'x20 Booths

- \*Member Rates: **\$800 per booth for members**
- Non-Member Rates: **\$900 per booth for non-member**

### 20'x20' Booths

- \*Member Rates: **\$1500 per booth for members**
- Non-Member Rates: **\$1600 per booth for non-member**

## Tabletops:

**\$100 per tabletop**

## Outdoor Booths: 10'x10'

- \*Member Rates: **\$200 per booth for members**
- Non-Member Rates: **\$300 per booth for non-member.**

## Set-Up:

- Booth set-up begins: Thursday, March 23rd from 12:00pm – 6:00pm
- Booth set-up is also Friday, March 24<sup>th</sup> from 8:00am – 11:00 am
- **ALL BOOTHS MUST BE SET UP BY 11:00AM ON FRIDAY, MARCH 24<sup>TH</sup>**
- **BOOTHS THAT ARE NOT SET BY 11AM WILL INCUR A \$400 PENALTY AND WILL NOT BE ADMITTED TO THE SHOW ON FRIDAY**

## Tear-Down:

- Booth tear-down begins: Sunday, March 27<sup>th</sup> at 4:01pm-6:00pm
- **BOOTHS THAT TEAR-DOWN EARLY WILL INCUR A \$400 PENALTY**
- All displays need to be removed by Monday, March 27<sup>th</sup> at 11:00am
- Any booths not removed by Monday, March 27<sup>th</sup> at 11:01am will be removed and a **\$400 PENALTY will be assessed. Displays removed by BANCI run the risk of being discarded.**

## Security:

- Proof of liability insurance must be received prior to show start
- Insure your displays and products to cover theft/damage
- BANCI is not responsible for lost or stolen items
