### Tear-Down:

- Booth tear-down begins: Sunday, March 24th at 4:01pm-6:00pm
- **BOOTHS THAT TEAR-DOWN EARLY WILL INCUR A \$400 PENALTY**
- All displays need to be removed by Monday, March 25th 8:00am- 11:00am
- Any booths not removed by Monday, March 25th at 11:01am will be removed and a **\$400 penalty will be assessed. Displays removed by BANCI run the risk of being discarded.**
